
According to the 2015 U.S. Transgender Survey:

The Human Rights Campaign (HRC) reports that since 2015, an average of 22 transgender and gender non-conforming (TGNC) people suffered from fatal violence.



HRC estimates that Black trans women/femmes experience a violent killing rate roughly **five times** that of the general population.

A pattern of behaviors used by one partner to maintain power and control over another partner in an intimate relationship

Also known as domestic abuse or dating violence, IPV is prevalent and can include various forms



Remember: no one deserves to experience abuse in any capacity and every type of abuse is serious. If you recognize any of these warning signs in your relationship, you should consider seeking help.

IPV IN LGBTQ+ RELATIONSHIPS

While dynamics of abuse can be similar for all relationships, queer+ folx may face specific abuse tactics and barriers to help based on their gender identity, gender expression, and sexual orientation.



Specific tactics can include:

- Disregarding or challenging your pronouns or identity
- Threatening to disclose your identity to family, friends, or coworkers
- Reinforcing homophobia, transphobia, or biphobia
- Falsely blaming your expression or identity for the abuse
- Shaming you for decisions you make regarding sex, intimacy, or expression
- Controlling access to gender-affirming care or items (i.e. hormone therapy, clothing)
- Attempting to isolate you from your community/affirming support network

SERVICES WE OFFER

24 HOUR HELPLINE

Our dedicated helpline advocates are trained to assess crisis situations, provide safety planning, complete shelter screenings, connect you to community resources, and provide empathetic support without judgement. We operate all year round, at all times.

EMERGENCY SHELTER

We provide secure, temporary shelter for survivors fleeing domestic abuse in Alachua, Union, and Bradford counties. Our campus is staffed by trained advocates and case managers. Clients of any gender expression, gender identity, and sexual orientation are welcomed.

LEGAL ADVOCACY

Our legal team assists clients with filing for injunctions and protective orders against domestic violence, dating violence, sexual assault, and stalking. We can also provide referrals for other legal matters.

TRAUMA COUNSELING

Our organization partners with local mental health resources to connect our clients with counselors. You can ask about seeing an LGBTQ+ identified professional.
